Avocat au Conseil d'État et à la Cour de cassation depuis 2005, il exerce au sein du cabinet Piwnica et Molinié. Parallèlement à son activité professionnelle, il effectue de nombreuses missions pour l'Ordre des avocats au Conseil d'État et à la Cour de cassation. Il est, notamment, membre du bureau d'aide juridictionnelle de la Cour de cassation (2006-2012), chargé d'enseignements de l'Institut de formation et de recherche des avocats aux conseils - Ifrac (2012-2016) et délégué pour la mise en place de la dématérialisation des procédures devant le Conseil d'État et la Cour de cassation ainsi que l'Open data judiciaire (2006-2016). Ancien membre du Conseil de l'Ordre, il a exercé les fonctions de président de l'Ordre entre 2021 et 2023.

Depuis 2024, François Molinié est également président de la Société de législation comparée et vice-président du Comité de liaison des institutions ordinaires (CLIO).

**François Molinié.** Barrister at the Conseil d'État and the Cour de cassation since 2005, he practices with Piwnica & Molinié. In addition to his professional activities, he carries out numerous assignments for the Ordre des avocats au Conseil d'État et à la Cour de cassation. In particular, he is a member of the legal aid office of the Cour de cassation (2006-2012), a lecturer at the Institut de formation et de recherche des avocats aux conseils - Ifrac (2012-2016) and a delegate for the implementation of the dematerialisation of proceedings before the Conseil d'État and the Cour de cassation as well as judicial Open Data (2006-2016). **Béatrice Castellane** is an independent arbitrator in business and investment cases. Professor Dr Comair-Obeid is the founding partner of Obeid & Partners and heads the firm's dispute resolution practice since 1987. She is an Associate Member at 3VB Barristers Chambers in London, and member of the Beirut Bar and the Paris Bar.

Prof Comair-Obeid has been identified amongst the world's foremost arbitrator practitioners by internationally renowned legal publications, referring to her as "grand dame of Middle East arbitration", "legendary lawyer" who is "really prepared, knows the issues and gets it right".

She has been actively involved in more than 170 domestic and international investment and complex commercial arbitrations as a party appointed arbitrator, chairperson, sole arbitrator, counsel and expert in Arabic, French and English-language. She has been engaged in mega construction projects in the MENA and have developed an expertise and knowledge of complex construction disputes in the region. She regularly deals with contracts based on FIDIC forms of contract with Sharia law influences and has extensive knowledge in the legal principles of the applicable substantive law in the MENA region. Through her comparative legal expertise and technical skills, she performed with professional excellence and gained the reputation of a specialist in this industry. She has been identified Arbitrator Intelligence's Presiding Arbitrator of the Year for 2020.

Throughout her career, Professor Comair-Obeid has held and continues to hold pre-eminent positions in many of the major institutions. Professor Dr Comair-Obeid publishes prolifically and is regularly invited to lecture at world renowned academic institutions where her articles and scholarly publications are often cited as reference works.

Professor Comair-Obeid is also a Professor of private law and international arbitration at the Lebanese University, visiting Professor at University Panthéon-Assas Paris II, and lecturer at University of Oxford for the CIArb International Commercial Arbitration Diploma.



**Antonio Crivellaro** is a former Professor of International Law and International Trade Law. He founded the International Arbitration Practice at BonelliErede. He has extensive experience (almost 350 cases) in international (commercial and investment) arbitration as either counsel, or arbitrator, or chairman under the auspices of ICC; ICSID; LCIA; Permanent Court of Arbitration-PCA; Stockholm Arbitration Institute; Cairo Centre; Vienna Arbitration Center-VIAC; FED (arbitrations for projects financed by the EU); Bangkok Centre; Milan Chamber; Dubai-DIAC Arbitration Centre, Bahrain Arbitration Chamber, and ad hoc proceedings.
